Thank you for your interest in working with our owners and our company. Folly's Best Rentals, Inc. manages property for a number of owners and on occasion we are asked to have vendors perform services for them. When this occurs there are a few things that will make the process work much more smoothly. We have outlined those below.

We require proof of Workers Compensation Insurance from all vendors whom we are asked to pay on the owners behalf. You can have your carrier forward a certificate of insurance to:

The Internal Revenue Service requires that we collect a completed W-9 for all vendors. Attached please find a blank w-9 that we need completed. This will also allow us to add you to our accounting software so that we can promptly process your invoice.

Invoices can either be mailed, e-mailed or hand delivered.

Billing Detail: The following information must appear on a invoice in order for it to be paid. Incomplete information will cause a delay in your payment as we cannot process an incomplete invoice. If you need any additional information please contact our office prior to sending an incomplete invoice.

The invoice must contain the following in order to be processed.

The P O number should be the name of the person requesting the work. This must be the owner of the property or a Folly's Best Rentals Employee for us to pay the invoice on the owner's behalf.

Part I Taxpayer Identification Number (TIN)

Part II Certification

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Future developments. For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to www.irs.gov/FormW9.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.
